2. **Technical bid-**

Envelope –I should contain of Earned Money Deposit and other certificates/ Technical documents i.e. Certificate with reference to non-black listing of firms, 3 years work experience alongwith -GST Number, PAN and certificate of authorized dealership and other supporting documents for technical evaluation.

Envelope –II should contain financial bid indicating item wise price + taxes extra.

Both, technical bid & financial bid should be sealed by the bidder in separate cover duly superscribed and both these sealed cover are to be put in a bigger cover which should also be sealed and duly superscribed.
3. The bidders are required to submit the documents as prescribed in check-list mentioned at **Annexure-B**.

4. The requirement of Fire safety measure can be increased or decreased as per actual requirement of Holiday Home Society (Regd.).
5. All tender documents including technical and financial bid must be duly signed by tenderer/bidder.

ANNEXURE-D

Terms & Conditions of contract:

1. The Dealers/Distributors/Suppliers/manufacturers must have authorized certificate of dealership/distributorship issued by the company/manufacturer or MSME made in India manufacturer.
2. The due date and time for receipt of tenders is upto **11.00 AM on 15.11.2021**.
3. The tenders shall be opened in the presence of intending tenderers or their authorized representatives if they wish to be present at that time as per notice.
4. The tender will be submitted in two parts i.e. Technical bid and financial bid. The bid shall be submitted on or before the due date.
5. The firm must have at least minimum turnover of Rs. 4 Lakhs per annum in the last three years.
6. The firm must have at least three years experience in the field.
7. The technical bid will be opened as per scheduled date and time. Thereafter short list parties who fulfill the technical criteria laid down for the purpose will be entertained for opening of financial bid. The decision of short listing of technical bid by the Jt. Secretary, Holiday Home Society (Regd.) will be final and binding upon all.
8. The tender shall be awarded on the basis of lowest quoted consolidated rates. No enhancement of rates shall be made during the contract period in any circumstances..
9. Tender documents should be signed by the authorized signatory along with seal of the firms.
10. The offer of tender will be valid for a period of 90 days from the date of opening of tender. Withdrawal of offer during this period will result into forfeiture of earnest money.
11. Tender must be accompanied with Earnest Money as mentioned in the tender notice in the shape of Demand Draft in favour of Holiday Home Society (Regd.) payable at Chandigarh. Incomplete/conditional tender or tender received without earnest money shall not be considered and liable to be rejected out rightly.
12. The rates are to be quoted by the bidders in Indian rupees only plus taxes extra Payment shall be made to successful bidders in Indian Rupees only. Any statutory liability such as applicable tax etc should be mentioned separately in the financial bid. The rates quoted should be FOR destination.
13. Rates should be mentioned both in figures as well as in words
14. The product should bear minimum one year warranty of replacement.
15. The successful bidder required to submit Performance Security @5% of total cost of the work.

16. The work should be completed within 30 days from the date of work allotment letter.
17. Successful tenderers will be required to supply the material at FOR destination. If the supply is rejected due to manufacturing defects, the tenderer shall lift the material at its own cost.
18. ISI number should be marked/engraved on all the materials.
19. Payment will be made against physical delivery and fixing of material and acceptance of the same by the constituted inspection committee of Holiday Home Society (Regd.), Chandigarh.
20. If the contractor fails to complete the services within 30 days then penalty levied will be levied @ 0.5% per week or part thereof.
21. The successful tenderer will have to furnish an affidavit that the quoted rates in the tender are not more/higher than the rates already quoted anywhere in any State transport Undertaking/any Govt. Organization/PSUs/Board/Corporation. If it is found that the quoted rates are higher than the rates quoted in any other Govt. /PSU supplies, the total difference of rates/prices will be recovered from the manufacturers.
22. In case bidder withdraws its offer within the validity period, submit forged/fake documents or do any unethical/un-business like activity, do not accept the supply order, EMD of the manufacturer will be forfeited and action will be taken as per rules.
23. The Dealers/Distributors/Suppliers/manufacturer has to furnish an affidavit along with the tender documents “that the dealers/distributors/suppliers has not been blacklisted or debarred in the past from doing any business in this field in any state transport/undertaking/any Govt. Organizations/PSUs or any govt. agencies in India”
24. The selected bidder shall not assign or sublet the contract supply order to any Sub contractor/firms.
25. Each page containing terms & conditions of the tender should be signed by the tenderers with stamp of the Dealers/Distributors/Suppliers or manufacturers.
26. The Holiday Home Society (Regd.), Chandigarh reserves the rights to modify/revoke the order/agreement/cancel this bid without assigning reasons.
27. Force Majeure: If the performance of bidders is prevented/delayed by any force majeure events, the party shall not be made liable for the loss of damage due to delay or failure to perform during the currency of force majeure. The work shall

be resumed as soon as practicable after the force majeure event ceases to exist.

28. **Arbitration:** In the event of any dispute and difference arising out of or in any way touching on concerning this contract, the matter whatsoever shall be referred to the sole arbitrator i.e. Secretary, Holiday Home Society (Regd.), Chandigarh or any other officer authorized by him, whose decision shall be final and binding on both the parties. The venue of arbitration shall be only at Chandigarh, U.T. (India). The contractor shall not object that the Arbitrator/ Secretary, Holiday Home Society (Regd.) Chandigarh or any other officer authorized by the arbitrator may deal with the subject matter in his official capacity.

29. **Jurisdiction:** Any dispute or difference or claim etc., shall be subject to the exclusive Jurisdiction of the Courts situated at Chandigarh only.
